- your [2024-25 FAFSA](#) has been received,
- all requested documents have been submitted to our office,
- you are registered for your summer classes, and
- you continue to meet all other eligibility criteria (e.g., satisfactory academic progress, etc.).

### SECTION 1: IMPORTANT SUMMER FINANCIAL AID FACTS TO UNDERSTAND

- **ENROLLMENT REQUIREMENTS:** You must be enrolled full-time (12 credits minimum) to be eligible for Lewis & Clark institutional financial aid (e.g., Lewis & Clark Grant, merit-based scholarship, etc.). You must be enrolled at least half-time (6 credits minimum) to be eligible for federal financial aid (e.g., direct loans, etc.).
- **LIMITED SEMESTERS OF INSTITUTIONAL AID:** Receiving financial aid during the summer will use one of your remaining semesters of financial aid eligibility. It should result in you graduating at least one semester earlier than you otherwise would have graduated.
- **PRORATED AID:** Summer tuition charges are significantly discounted, in comparison to the tuition charges for the typical fall/spring semesters. Therefore, eligibility for institutional funding, (e.g., Lewis & Clark Grant, merit-based scholarship, etc.) is prorated for summer. EXAMPLE: "Student A" enrolls in 12 credits for summer. If summer per credit tuition is \$1,000, and their Lewis & Clark institutional aid usually covers 25% of tuition during the regular academic year, Student A's summer prorated Lewis & Clark aid would be \$3,000 (based on 12 credits x \$1,000 = \$12,000. And, \$12,000 x 25% = \$3,000).
- **FEDERAL FUNDING LIMITS:** There are no additional Federal funding sources for summer, and most Federal aid programs (e.g., Federal student loans, etc.) have regulated annual maximums. Using these funds in summer will reduce the amount available to you for both Fall 2024 and Spring 2025 semesters. If you plan to enroll for Summer/Fall/Spring, it means Federal funds will be split evenly over the three semesters. EXAMPLE: If the annual maximum of a Federal aid source is \$4,500, it will be offered at \$1,500 per semester for Summer/Fall/Spring award, as opposed to \$2,250 per semester for Fall/Spring only.
