Work has included:

- debunking the legal claims of Japan and Korea, which they claimed prevented them from providing vessel-specific fishing data to the Western and Central Pacific Fisheries Commission (WCPFC); they now provide that data.
- determining that high seas transshipment in the WCPFC was not “impracticable;” the issue is now considered a “high priority” for the WCPFC.
- preparing legal opinions for the Convention on Migratory Species on compliance regimes, live capture of cetaceans, and the national legislation program, all of which led to new mechanisms (compliance, review of national legislation) and strengthened regimes (live capture of cetaceans, rules of procedure).
- providing legal and technical advice to members of the International Whaling Commission (IWC) that led to structural changes for proposing and adopting aboriginal subsistence whaling quotas.
- serving as an official legal advisor to Luxembourg (2016) and the United Kingdom (2001) at IWC meetings.
- providing legal advice on implementation issues, including those relating to elephants, tigers, and issuance of permits for high seas catches, to NGOs and governments relating to the Convention on International Trade in Endangered Species (CITES).
- providing legal advice to the CITES Secretariat on diplomatic immunity, rules of procedure, and the relationship between CITES and the SPAW Protocol; the advice on diplomatic

- immunity allowed a party to confiscate ivory from a diplomat.
- drafting a sea turtle conservation treaty for Costa Rica, Nicaragua, and Panama, which Costa Rica and Panama signed.
- providing legal and technical support to Pacific Island Developing States in the climate change negotiations.
- providing advice to the Korean Ministry of Environment concerning Korea's positions for financing for the Green Climate Fund and on the issue of loss and damage.
- analyzing laws, policies, and institutional structures and drafting legislation for the government of Mauritius on the protection of environmental sensitive areas.
